The Rector of Udayana University has determined the admission results for new student intake through the Independent Admission Selection for the International Master Program for the Odd Semester of the Academic Year 2026/2027, with the following provisions:

1. Each applicant may check their admission result online on May 26, 2026, at 6:00 PM Bali Time (WITA) by logging into the Admission website at: <https://admission.unud.ac.id/login>. Applicants must use the same account that was used during the admission registration process.
2. Applicants who are declared successful in the selection system are required to complete the online registration through the Admission website by clicking the "Continue" button. The registration process as a new student must follow the procedures and schedule stated in Attachments 1 and 2 of this announcement.
3. Applicants who have completed the online registration form are required to upload scanned copies of all required registration documents in accordance with the format specified in the system.
4. After the registration documents have been validated, applicants may pay the tuition fees using the Virtual Account Number from any selected bank in accordance with the amount stated on the Admission website.
5. After completing the tuition fee payment, each applicant may download and print their Student Identification Number (NIM) through the "New Student Information" menu on the Admission website.
6. Tuition fee payments made after the payment deadline, namely on May 26- June 8, 2026, will not be accepted and the applicant will be considered to have withdrawn as a prospective student of Udayana University.
7. Tuition fees that have already been paid are non-refundable under any circumstances.

## Attachment 1

### **REGISTRATION PROCEDURES**

All prospective new students of Udayana University who are declared successful in the International Master Program Selection for Academic Year 2026/2027 are required to follow the registration schedule and procedures as follows:

#### **1. COMPLETION OF THE REGISTRATION FORM**

- a. The online registration form may be completed from May 26 to June 8, 2026.
- b. The online registration form must be completed through the Admission website at <https://admission.unud.ac.id> by logging in first. Applicants must use the same account used during the admission registration process.
- c. After completing the form, applicants must upload the required registration documents.

#### **2. UPLOADING REGISTRATION DOCUMENTS**

All required registration documents must be uploaded through the Admission website after logging in. Prospective students must prepare softcopy (scanned files) of the following documents:

- a. Original diploma certificate or legalized photocopy,
- b. Original academic transcript or legalized photocopy,
- c. Drug-Free Certificate issued by the National Narcotics Agency (BNN), a government hospital, or a trusted hospital,
- d. Statement Letter signed by the applicant and parent/guardian (the template can be printed from the system, completed, and signed),
- e. Statement of Willingness to Pay Tuition Fees that has been fully completed and signed by the applicant (the template can be downloaded from the system),
- f. The maximum file size for each required document is 500 KB in PDF format.

Documents uploaded to the Admission system will undergo verification and validation by the registration committee. After the registration documents have been validated, prospective students may proceed with the tuition fee payment.

#### **3. TUITION FEE PAYMENT**

Tuition fee payment may be made from May 26 to June 8, 2026, through any bank selected in the Admission system using the Virtual Account Number according to the amount stated on the Admission website.

#### **4. GENERATION OF STUDENT IDENTIFICATION NUMBER (NIM)**

After the payment process has been successfully completed, the Student Identification Number (NIM) will be generated online and the data will be validated by the registration committee.

#### **5. DOWNLOADING THE STUDENT IDENTIFICATION NUMBER (NIM)**

After the validation process by the registration committee has been completed, new students may download their NIM through the Admission website by logging back into the online system via the "New Student Information" menu.

## 6. ADDITIONAL INFORMATION

- a. Drug testing is mandatory for all prospective new students because the laboratory drug test result must be uploaded as one of the registration requirements.
- b. There will be no extension of the registration period, including for tuition fee payment and document upload deadlines, and registrations submitted outside the specified schedule will not be processed.
- c. Prospective students who fail to complete the registration and tuition fee payment according to the specified schedule and procedures will be considered to have withdrawn from the admission process.
