1. Admission Requirements:

- a. **Indonesian citizens (WNI):** Hold a relevant degree from an accredited institution or an overseas degree officially recognized in Indonesia.
- b. **Foreigners (WNA):** hold a diploma/degree in a field of study relevant to the selected study program.
- c. English Proficiency Test (**EPT**) with minimum scores: TOEFL ITP 400 / TOEFL iBT 133 / TOEIC 405 / IELTS 5.0 / Duolingo 100.
- d. Applicants from English-speaking countries are exempt from submitting English proficiency scores.
- e. Academic transcripts: Grades 10–12 (for Indonesian applicants) or high school academic reports (for international applicants, in English).
- f. Motivation letter.

 - Motivation letter.
 - Passport photo (jpg format, max. 600x800 pixels, 300 KB) (for international students).
 - Valid passport/ID scan.
 - Financial guarantee statement.
